**Publication Dates and Circulation**

The Florida Bicycle Messenger is published quarterly on March 15, June 15, September 15, and December 15. The newspaper is mailed to approximately 1600 active members, bicycle/pedestrian coordinators and professionals, elected officials, corporations, bicycle clubs and stores, and other state and regional bicycle advocacy organizations for an approximate total of 2500 issues. We print 3000 copies that are further distributed at special events.

**Format**

The Florida Bicycle Messenger is printed using a 16-page 11.375 x 13.75" format on 35# Hi-Bright paper, 4 color on 8 pages and the balance black. No bleeds. Best resolution for submitted images is 300 ppi.

**Due Dates and Terms**

Advertisements are due by 5:00 pm on each of the space reservation dates prior to the next quarterly issue: February 15, May 15, August 15, and November 15. Payment is due on placement of advertising order and before publication. We will send you a copy of the newspaper upon publication.
